After any resolution is made during a Board meeting, a Board meeting resolution document is typically prepared to detail-out specifics of the resolution. A Board Resolution is a legally binding document for your company and you should keep it with company records for future reference of decisions made by your Board of Directors.

Board Resolution Sample Format. This sample format has a heading called board resolution followed by the name of the company. In the first paragraph the name of the board of directors along with date is mentioned. In the next paragraph the real resolution is stated. You may also see meeting agenda samples.

Format the resolution by putting the date and resolution number at the top. If it's the boards first resolution, you can number it whatever you want. Consider using something like 0001 and then giving all future resolutions a consecutive number.

You may be surprised to learn that a board resolution should be simple and concise. As demonstrated in the board resolution sample that follows, a board resolution merely describes the action that the board agreed to take and shows the date of the action and names the parties to the resolution.
